ASEAN does not capable press Myanmar government to finish Rohingya case because the principle of non - intervention adopted by ASEAN members. The principle This obstruct assistance from ASEAN countries in finish the conflict that caused conflict prolonged without settlement so that Conflict between Myanmar and Rohingya is increasing peak in violence and violations right basic serious human being.

Aceh is one of the objective main for Rohingya refugees because location its strategic geography as part from route migration refugees in the Southeast Asia region. Conditions Aceh's geography borders direct with waters international, such as the Strait of Malacca, making it become point important landing for Rohingya refugees fleeing self from conflict in Myanmar. Acehnese people often treat refugees with empathy and solidarity, which makes it become interesting destination for Rohingya refugees seeking protection. In this case, the Aceh Regional Government together with the DPRA took step for respond problem arrival Rohingya refugees with compile draft Qanun on Handling Refugees from Abroad in Aceh. This step show seriousness Aceh Regional Government in handle issue and also ensure that policies produced own runway strong and appropriate law with context local Aceh. With Thus, the steps this is also a part from securitizing move efforts undertaken by the Aceh Regional Government to overcome challenges faced related with arrival Rohingya refugees.

This study emphasizes the strategy taken by the government Aceh region in secure public local who feel threatened by the existence of Rohingya refugees in Aceh. In the study this, writer to argue that Handling the Aceh Regional Government has done through three draft main securitization that is securitizing move, referent object and existential threat, as well extraordinary measures. The Aceh Regional Government plays a role as the actor who carries out securitizing move with emit policy of the Qanun Bill on Handling Refugees from Abroad in Aceh as derivative from Regulation President Number 125 of 2016 concerning Handling Refugees from Abroad. Acehnese people are placed as referent object, while arrival refugees Rohingya ethnic group is considered as existential threat that must be handled.

Form response emergency given covers various policy strategic and cooperative for protect public Aceh related areas arrival Rohingya refugees. The Aceh Regional Government has determined location appropriate shelter for avoid concentration refugees in a particular area, based on a study that takes into account regional capacity

and its impact. Implementation facility adequate health by the Aceh Regional Government. In addition, there is a support program psychosocial provided for refugees and communities local for dealing with trauma and building solidarity. Local communities and leaders custom involved in taking decision so that the policy in accordance with culture local and get support community . Securitization process is the mechanism by which actors who have roles and authorities important in government, such as state officials, state agencies, figures society and organizations international identify and respond perceived threat threaten sustainability object or interest certain (Dharmaputra, 2017). Actors this , is called as "securitizing actors" who play a role in secure and protect object said. The first step in the process of securitization is identify threat serious that can endanger object certain. This Can originate from various aspect like economy, health, and security. Furthermore, securitizing actors convey statement public For emphasize existence threat said, with objective convincing audience that threat This real and necessary followed up (Tamsyah

& Hidayat, 2022). With frame threat as problem big for audience, securitizing actor to obtain legitimacy For carry out action necessary precautions. By overall, can it is said that, securitization is a process where actors important in government identify and respond threat to object or protected interests through declaration public For get trust audience and implementation action outside normal For overcome threat the (Muhaimin, 2018). In context this, securitization still involving identification threats and actions outside normal, but more depend on action practical and policy direct than declaration public.

Securitizing Actor

Securitizing actor in study This is officials and agencies Aceh Regional Government, which consists of from Governor of Aceh, Aceh Health Service, Aceh Disaster Management Agency Aceh Disaster Management Agency (BPBA), as well as agency related others. With existence improvement amount refugees Rohingya ethnic group who came to the Aceh region, the Aceh Regional Government as securitizing actor feel need take action prevention on the threats that arise. This is in accordance with not quite enough answer Aceh Regional Government for protect and guard order communities in their area. Based on data from UNHCR, the number of Rohingya refugees who arrived in Aceh in a number of year final Keep going increased, where since beginning his arrival in 2015, soared around 319 refugees until in Aceh. Until finally in 2023, there were 12,295 refugees registered with UNHCR, including 69 % adults consisting of of 72% men and 29% women, and 29% children. This can Viewed from January to December 2023, as many as 1,752 Rohingya refugees were disembarked of 11 ships in several locations in Aceh and North Sumatra (Unhcr.org, 2023). The existence of These Rohingya refugees cause significant impact, where they need facility base like place stay, food and service health that has been add load on source Power local. In addition, concerns about potential distribution disease and improvement act crime also emerged. Therefore that, for still guard order and welfare Acehnese people, Aceh Regional Government takes steps practical for manage situation This without do declaration explicit public.

First step to take The Aceh Regional Government is tighten supervision in the area borders and coasts, improving patrol security, and work the same with institution international For Handling refugees (Batubara, 2023). Furthermore, the Aceh Regional Government is working the same with various stakeholders interests, including government centers, non- governmental institutions, and organization international through discussion closed and meeting coordination For manage situation refugees without need announce it in a way public (Mumtazainur, 2020). On the other hand, assistance social provided by the Regional Government selective to individual, family, or public for protect from risk social that is possible happen, help This can in cash or goods certain (Setiawan, Saputra, & Wahyudi, 2020).

Second, Supervision Strict To Rohingya refugees. Supervision strict is a very important strategy in context Handling Rohingya refugees in Aceh (Putra, 2023).
